

TOURIST VISA REQUIREMENTS

- Online form and Embassy-issued form (visa.immigration.gov.ng).
- Invitation letter from the person inviting you to Nigeria (with signature, date, contact telephone number and assuming immigration responsibility of the invitee, as well as the type of visa for which you are applying) or letter addressed to the embassy explaining the reason for the trip, confirming date of arrival and departure, as well as place of stay.
- Copy of the valid passport of the person signing the letter of invitation.
- Flight itinerary (**NO PHYSICAL TICKET OR TICKET PURCHASE NECESSARY, ONLY THE ITINERARY**).
- 2 passport-size colour or black and white photographs (3.5 cm x 4.5 cm).
- Applicant's original passport.
- Employment letter or valid work credential (of both the applicant and the person inviting).
- Bank statements not older than 3 months (**BOTH OF THE PERSON TRAVELLING AND OF THE PERSON WHO INVITED**).
- Valid official identification (INE, driver's license or passport).
- If you are a foreigner, you must present a valid residency document issued by the Mexican National Institute of Migration.
- Copy of proof of yellow fever vaccination and malaria treatment (your original documentation must be presented at the airport upon arrival in Nigeria).

Documentation must be submitted with two (2) copies of each document (except forms and proof of payment).

BUSINESS VISA REQUIREMENTS

- Online form and Embassy-issued form (visa.immigration.gov.ng).
- Invitation letter from the person inviting you to Nigeria specifying the type of visa (with signature, date, contact telephone number and assuming responsibility for immigration of the person inviting you, as well as the type of visa for which you are applying) or letter addressed to the embassy explaining the reason for the trip, confirming date of arrival and departure, as well as place of stay.
- Copy of valid passport of the person signing the letter of invitation (if the person is a foreigner in Nigeria, a copy of Nigerian residency must be submitted)
- Company's certificate of incorporation.
- Copy of valid passport of the person signing the letter of invitation.
- Flight itinerary (**NO PHYSICAL TICKET OR TICKET PURCHASE NECESSARY, ONLY THE ITINERARY**).

- Original passport.
- 2 passport-size colour or black and white photographs (3.5 cm x 4.5 cm).
- Valid official identification (INE, driver's license or passport).
- If you are a foreigner, you must present a valid residency document issued by the Mexican National Institute of Migration.
- Copy of proof of yellow fever vaccination and malaria treatment (your original documentation must be presented at the airport upon arrival in Nigeria).

For minors, the above documentation is required, plus the following:

- Copy of birth certificate
- Copy of both parents' passports
- Travel authorisation letter (signed by both parents and accompanied by copies of identification documents other than passports)

Documentation must be submitted with two (2) copies of each document (except forms and proof of payment).
